

PUBLIC INPUT MEETING REPORT

March 1, 2013

Process Overview

On Monday, February 11, 2013, a Notice of Public Input Meeting was mailed to all property owners that lie within 500 feet, but a minimum of three parcels in depth in each direction of the legal boundary of the subject property. This resulted in 195 property owners being notified. The meeting notice, certificate of this mailing, and 11 letters marked as "Return to Sender" are attached to this Report. We did not receive any correspondence from any of the property owners leading up to the meeting.

Meeting and Discussion

The property owners in attendance were shown 6 exhibits prepared by the applicant. These exhibits consisted of: Site Location Map, Site Plan, Building Elevations, Prototypical Building Photographs, 3-D Building, Site, and Landscape Rendering, and a copy of the Variance Submittal Package. All 3 representatives of the applicant answered various questions regarding the development and requested variances. The main points of discussion are detailed below:

By and large, the residents in attendance were not in support of the proposed drive thru. They stated that they were previously promised by the City that there would only be 2 drive thrus allowed on the outparcels and that the outparcels would consist of upscale restaurants such as Cheesecake Factory. They stated that they had nothing against Panda Express, but it was the principal of the matter.

The applicant pointed several key differences between Panda Express and other fast food restaurants with drive thrus:

- Panda Express only does approximately 40% of their volume through the drive thru.
- Panda Express' projected volume for this store \$1.2 Million, which is approximately 25% of the volume of a McDonald's or Chick-fil-a.
- Panda Express' hours of operation are 11 AM to 9 or 10 PM at the latest.
- Panda Express is a not a franchise. It is corporately owned and operated.

Furthermore, the applicant pointed out that the layout of the proposed Site Plan was developed with the residents in mind:

- The building is located approximately 70 feet away from the Ridgewalk Parkway curb line.
- The drive thru lane is shielded from the view of Ridgewalk Parkway.
- The menu board is located over 200 feet away from the Ridgewalk Parkway curb line and faces inward towards the outlet center, thus minimizing any noise that would be heard by the nearest residential neighbor (who is lies across Ridgewalk Parkway).

Another point of discussion related to the look and feel of the Panda Express Bright and Fresh Prototype. The reaction was mixed. Some neighbors liked the look of the building prototype, while others did not care for it and wanted it to match the look of the remainder of the shopping center. The applicant explained that the photographs of the building were prototypical in nature and that the final building architecture would take elements from the rest of the shopping center and blend in an aesthetically pleasing manner.

Summary

As a whole, it was apparent that the 12 property owners' only concern was the fact that Panda Express had a drive thru. In fact, most people stated that they had nothing against Panda Express, generally they liked the Site Plan, and appreciated the information presented. They just did not want a third restaurant with a drive thru built anywhere on the outparcels.

Variance Application for Proposed Panda Express

Outlot #5 – Outlot Shoppes at Atlanta

You are invited to attend a Public Input Meeting to learn about a Variance Application submitted to the City of Woodstock for the development of Outlot #5 of the Outlet Shoppes of Atlanta located just east of I-575 on Ridgewalk Parkway.

The five (5) requested variances the applicant is seeking relief from are:

- The restriction, which only allows two restaurants with a drive-thru on two of the first three outparcels.
- The restriction, which requires all buildings to be built along a build-to line, measured no more than 18 feet from the back edge of sidewalk.
- The restriction, which requires all buildings to be built to cover a minimum of 60% of the frontage along the entire width of the parcel as measured from the build-to line.
- The restriction that requires all buildings to have a minimum of 1 functional entry facing the public street.
- The Architectural Standards as required by the Technology Park Overlay District.

The purpose of this Public Input Meeting is to provide you with details of our proposed development of Outlot #5 and ascertain your comments and feedback. Information available for your review will be the Variance Application Package, Site Plans, Architectural Elevations, and Color Renderings of the Proposed Site. Representatives from Panda Express will be available to answer any questions or address any concerns you may have with the development of this parcel.

The Public Input Meeting will be held at Magnolia Hall (108 Arnold Mill Road, Building C, Woodstock, GA 30188) on Tuesday, February 26, 2013 at 6:30 PM.




